Assessment and evaluation of signs and symptoms related to mental disorder among general population of Iraq and ISIS fighters

Background and Objectives: Most of the population worldwide is suffering from mental illness due to one reason, or other but very limited data is available specifically in Iraq. Iraq has had long history of wars and terrorist activities during the last four decades. Limited research is carried out that focus specifically on mental health and its related subheadings to understand the trends of research in this field. Therefore, this systematic review aims to understand the connection between the studies in a special period on mental health and the areas that these papers cover in this field.

Methods: by using the protocol of PRISMA, 33 full-length English language articles were searched in the major databases, (PubMed, EMBASE and MEDLINE). With the help of specific keywords like "mental health in Iraq," "anxiety," "depression," "Iraq survey," "Psychosis," "postpartum," "prevalence of mental illness in Iraq," "Prevalence of Mental disorders in Iraq." 14 articles were finally selected for further data extraction. Result: findings revealed a wide coverage of different factors like violence, war, individual with diabetes, stress environment, infertile women, parents of children with cancer, and old aged are responsible for the mental health problems. Topics such as child and adolescent mental health include hospital-based studies on psychiatric problems of children, community-based investigation on the mental health of a different group of minorities, the prevalence rate among different age groups child and adolescent population, and studies on prevention and intervention strategies for boosting mental health care in the area should be considered for further detail investigation.

Conclusion: This systematic review indicated that research in the mental health field needs to be reconsidered regarding the priorities and focuses according to the need of country. Though major factors have been identified but there is an uneven distribution of the present mental health situation and published studies.

A study of relationship between happiness and academic achievement among university students

The aim of the present research was to investigate the relationship between Happiness and Academic achievement among university students. Additional analysis was run to examine the gender differences in the level of happiness and academic achievement among university students. The sample of the present study consisted of two hundred and five (n =205) adult students including 102 males and 103 females. Sample was selected by using proportionate stratified random sampling technique. Data was collected using Subjective Happiness Scale by Lyubomtrsky & Lepper (1997) and academic achievement was measured by self-report grade point average (GPA). The data was analyzed by using SPSS (statistical package for social sciences) 21.0 Version. Descriptive statistics, Spearman rho, Mann-Whitney test were employed to analyze the research data. Results showed that there is a significant and positive relationship between happiness and academic achievement among university students. Results also exhibited significant differences between male and female with respect to their level of happiness. Limitations and Recommendations of the research are discussed.

Psychiatric Hospital Nurses' Attitudes Towards Trauma-Informed Care

TIC at the state psychiatric hospital in Malta. Statement of the problem: The high prevalence of trauma among mental health service users has been extensively reported. Consequently, the integration of a trauma-informed ethic in mental health care service delivery is being increasingly recommended. Service providers' attitudes towards trauma-informed care (TIC) are a particularly mensurable outcome for ascertaining whether a service is trauma-informed. However, research on mental health professionals' attitudes towards TIC is scant. Aim: This mixed method study was designed to gain an initial understanding of nurses' attitudes towards Methods: One hundred and thirty-six nurses completed the Attitudes Related to Trauma-Informed Care scale. Data were analysed using inferential statistics. A focus group interview among ten nurses ensued. Thematic analysis was used. Findings: Nurses demonstrated favourable TIC attitudes. Ambivalent attitudes for the subscale "Causes" were identified. Nurses employed for less than 5 years at the hospital and those in acute settings displayed more favourable attitudes on some subscales. Three themes "Awareness," "Unhealthy boundaries" and "Inhibition" emerged from qualitative analysis. Conclusions and significance: Challenges uncovered in the provision of TIC include the unacknowledged impact of trauma on challenging behaviour among nurses, the influence of blurred professional boundaries with long-term clients on the cycle of perpetuated trauma identified by previous research and nurses' work-related traumas. Identified challenges to TIC integration among nurses can facilitate the implementation of TIC in hospitals. TIC educational packages for nurses should acknowledge traumatic histories in the aetiology of challenging behaviour and stress the importance of maintaining professional boundaries with clients.
